LIFETIME LIMITED WARRANTY

Effective 01/01/06

Madison Vinyl warrants to you, the original purchaser of the Madison Vinyl Replacement Window that:

Basic Window Unit:

The rigid vinyl in the window is warranted against chipping, peeling, pitting, or blistering for as long as you own and reside in the house and is transferable to anyone who may purchase and reside in the house in which these windows were installed. This Limited Warranty does not apply to any damage caused by improper maintenance, fire, flood, explosion, misuse, abuse, vandalism, or other external forces. This Warranty does not apply to brown windows.

Insulated Glass Unit:

Insulated glass is warranted against stress cracks, breakage, or material obstruction of vision resulting from film, dust, or moisture collection between the interior glass surface of the insulated unit for a period of 20 years from the date of the unit. **(Warranty on glass covers glass and labor for 10 years if Madison vinyl installs the windows, Otherwise Warranty only covers Materials)** The date of manufacture is sandblasted on the corner of the glass pane. Condensation on any window surface does not indicate a defective window nor a faulty installation, but is the natural result of excessive moisture in the home and changes in temperature and humidity.

Moving Parts:

Moving parts, such as balances and locking mechanisms are warranted against defects in material and workmanship for a period of 5 year from the date of installation. This Limited Warranty does not apply to any damage caused by improper maintenance, fire, flood, explosion, misuse, abuse, vandalism, or other external forces.

Fiberglass Screens:

The materials used in manufacturing screens are warranted for as long as you own and reside in your present home and is transferable to anyone who may purchase and reside in the house in which these windows were installed. This Warranty does not apply to any damage caused by improper maintenance, fire, flood, explosion, misuse, abuse, vandalism, or other external forces. This Warranty shall be Limited to providing you with new screen materials and/or frames or spline for any manufacturing defect in the screen.

MADISON VINYL DOES NOT COVER THE COST OF LABOR OF REMOVAL OR INSTALLING ANY REPLACEMENT UNITS OR PARTS, **(IN EXCEPTION OF GLASS)**. SERVICE CALLS TO THE HOME ARE MADE AT THE PREVAILING RATE.

On some installations, silicone caulk is used to seal the window frames or trim package against water or air penetration. Caulking is normally considered a maintenance responsibility of the homeowner.

THE PROCEDURE FOR OBTAINING PERFORMANCE OF THE WARRANTY OBLIGATION IS SIMPLE. If you feel that your window is defective, contact the contractor that installed it for inspection. If the contractor or party performing the inspection believes a part to be defective, the part should be taken or sent, postage prepaid, to the address below along with proof of the date of installation.

Our factory inspection will then determine if the part complies with this Limited Warranty. If we determine that any defective part or parts comply with this Limited Warranty, we will replace the part with a new part according to the Warranty, within sixty (60) days of its receipt, FREIGHT COLLECT.

THIS LIFETIME WARRANTY IS MADE IN LIEU OF ALL OTHER EXPRESS WARRANTIES AND EXTENDS ONLY TO THE ORIGINAL CONSUMER PURCHASER. AFTER THE EXPRESS WARRANTY PERIOD EXPIRES, MADISON VINYL DISCLAIMS ALL IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL MADISON VINYL BE LIABLE FOR SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OR FOR ANY DELAYS IN THE PERFORMANCES OF THIS WARRANTY DUE TO CIRCUMSTANCES BEYOND ITS CONTROL.

Some states do not allow limitations on how long an implied Warranty lasts, or the exclusion or limitation of incidental or consequential damages, so that the above limitation may not apply to you. This Limited Lifetime Warranty gives you specific legal rights, and you may have other rights, which vary from state to state.

This Lifetime Limited Warranty shall not be effective unless you complete and return the registration certificate within thirty (30) days of installation. The registration certificate must be signed by the original purchaser-Property Owner and the Dealer and Mailed to MADISON VINYL within thirty (30) days of the completed installation.
